G3 – MANAGERS EDUCATION PROGRAM

Global Minerals industry Risk Management (G-MIRM)

G3 Manager Education is a four-day professional development course that develops managers' understanding, appreciation and application of risk management policy and procedures.

G3 is aimed at:

- Mine, project or section managers, superintendents, mine captains, plant supervisors, senior technical staff, safety managers and practitioners
- Division or corporate technical and functional staff (e.g engineering, ventilation, safety, human resources, finance and procurement)

Developed by the Minerals Industry Safety and Health Centre (MISHC) at UQ's Sustainable Minerals Institute, the G3 course is part of the Global Minerals Industry Risk Management (G-MIRM) program. It is facilitated by experienced instructors and regularly updated to reflect the latest research.

G-MIRM is a leading practice, globally available program which delivers practical and effective risk management solutions to enable a step change in operational risk management.

It aims to educate and equip the resources sectors with the

knowledge and skills to develop a risk management system and to enable effective decision making about risk.

Undertaking the G3 will help managers:

- Initiate a change in operational risk management by improving understanding and practice of risk management
- Challenge how individuals act, make decisions and lead teams in managing operational risk



Key Benefits

- Improve awareness and early recognition of hazards and risk
- Develop skills to scope a risk assessment and compare the results against good practice approaches
- Introduction to and training in practical tools for improved risk management
- Identify opportunities to strengthen internal procedures and policies
- Learn the benefits of a personal commitment to and accountability for risk management



Program Delivery

The G3 course consists of pre-study materials, a four-day intensive workshop and three submitted assessment pieces.

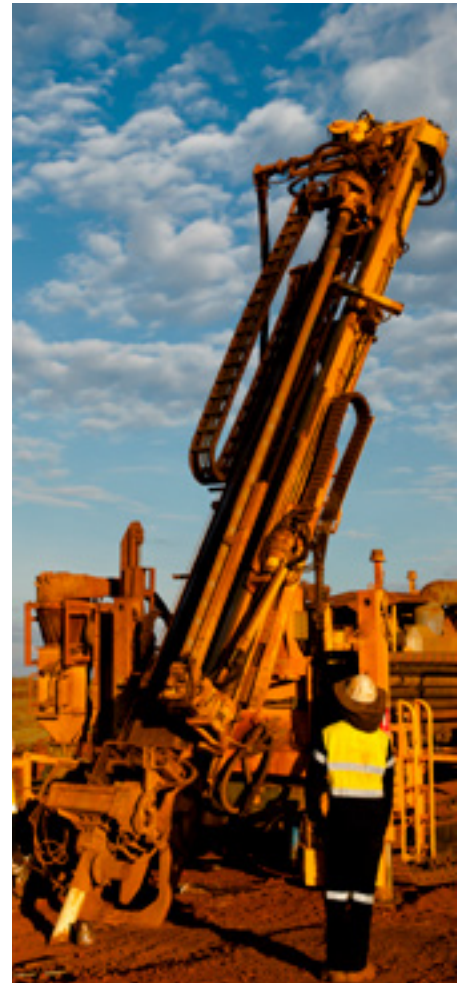
Prior to the course each participant is required to complete approximately 20 hours of pre-study consisting of readings and a module, hosted on UQ's online learning platform Blackboard.

The four day workshops run as a series of modules, with interactive exercises and approximately 90 minutes of reading and assignment work at the end of each day. Participants are required to complete three assignments to demonstrate adequate competency. Submission of these assignments is via Blackboard on a date agreed with the course presenter (normally 14 days after the course).

Competency Accreditation

Participants must successfully complete ALL three assignments with a grade over 75% in each to receive a Certification of Completion from The University of Queensland. This includes equivalency to the industry competency standard RIIRIS601D Establish and Maintain the Risk Management System as identified by the Coal Mining Safety and Health Advisory Council and the Mining Safety and Health Advisory Council in Queensland.

This course has been developed and delivered under the oversight of The University of Queensland Teaching and Learning Policies.
